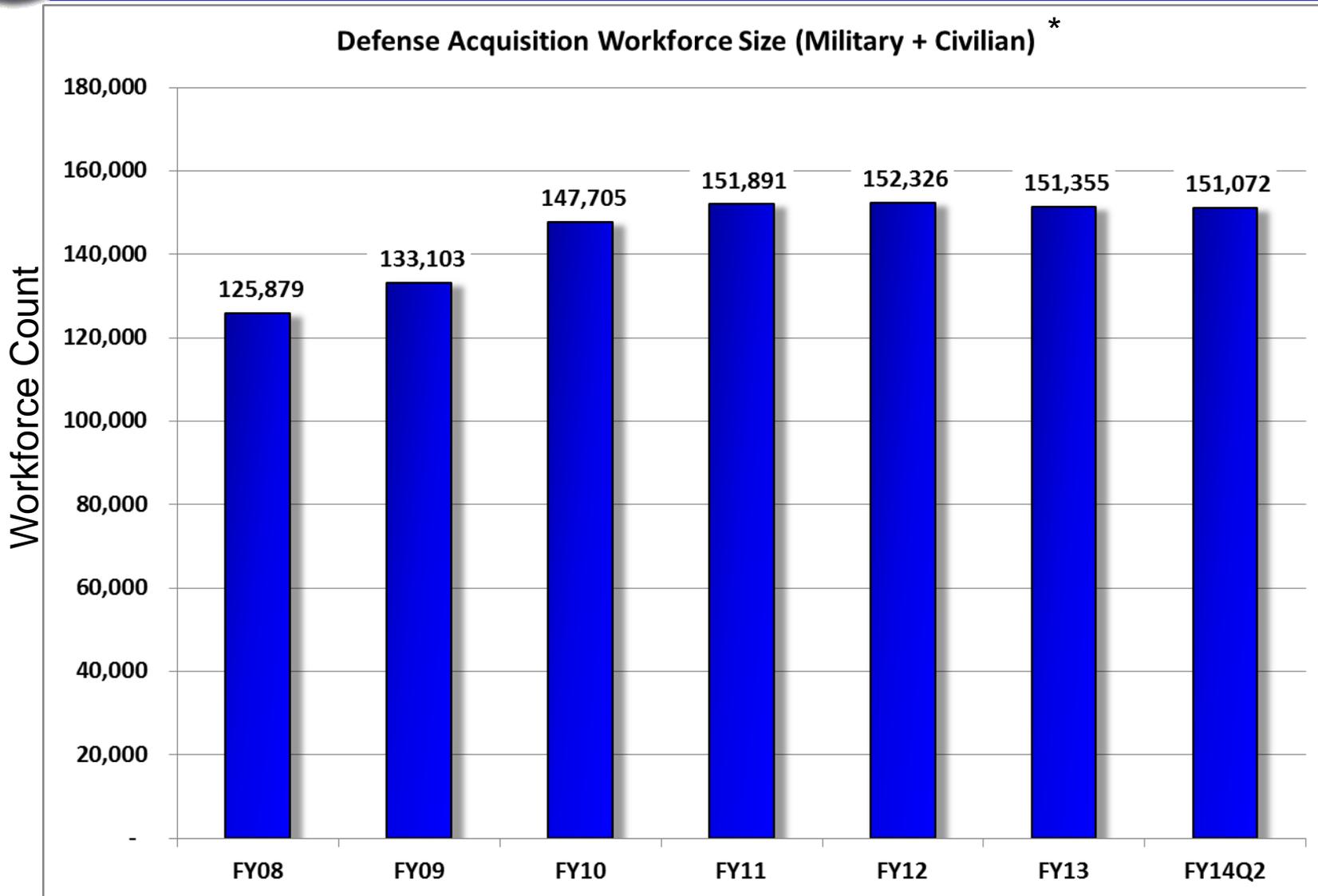



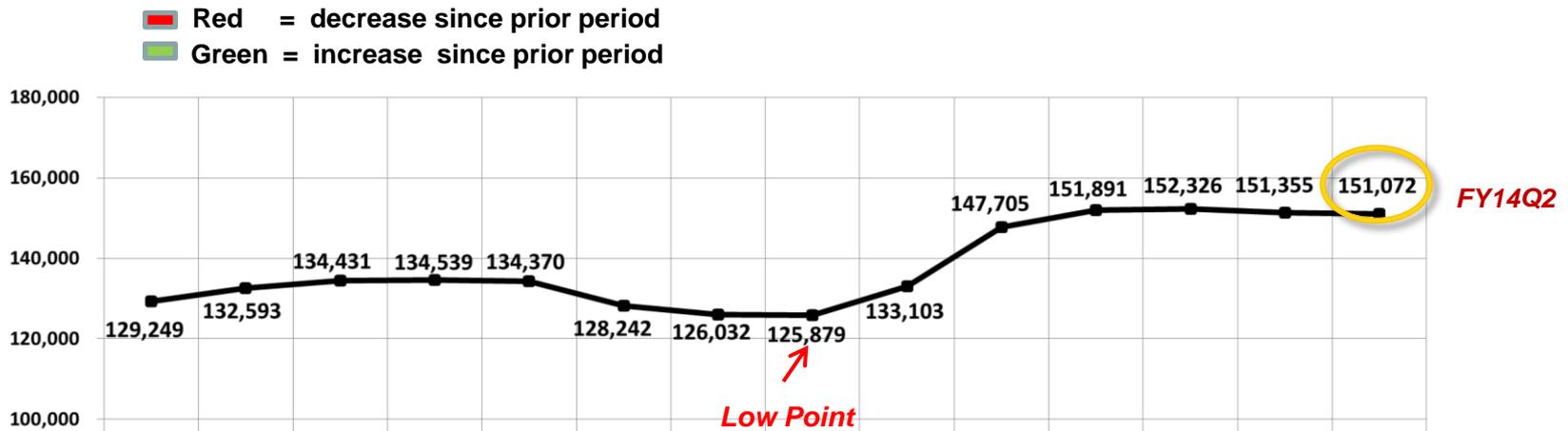



Certification Level "Meet/Exceed" Rates by Career Field AT&L (FY14Q2)



Certification Level "Meet/Exceed" Rates by Component Test and Evaluation (FY14Q2)







Gains and Losses by External to DoD, Internal to DoD, and Administrative Categories










