Defense Acquisition Workforce Size Highlights

- The current Life Cycle Logistics Defense Acquisition Workforce count is 17,642, up from 13,361 in FY08, a total increase of 4,281
- The Life Cycle Logistics Defense Acquisition Workforce count was at its highest point (17,642) in FY14Q3, and its lowest point (12,332) in FY06
- The Agencies with the largest increases, since FY08, are NAVY, DLA, and AIR FORCE, with increases of 1,229 (28%), 1,202 (3005%), and 1,127 (65%), respectively
- The Agencies with the largest decreases, since FY08, are DISA, PFFA, and DSCA, with decreases of 6 (-16%), 4 (-100%), and 2 (-100%), respectively

Defense Acquisition Workforce DAWIA Certification Highlights


- The current Life Cycle Logistics Defense Acquisition Workforce DAWIA Meets/Exceeds certification rate is 73.9%; up from 44.9% in FY08
- The current Life Cycle Logistics Meets/Exceeds certification rate is up 64.6% from FY08
- The current Life Cycle Logistics Defense Acquisition Workforce DAWIA 24 month grace period rate is 19.9%; down from 32.9% in FY08
- The current Life Cycle Logistics Defense Acquisition Workforce DAWIA Does Not Meet certification rate is 6.1%; down from 22.2% in FY08

Defense Acquisition Workforce DAWIA Retirement Eligibility Highlights

- Senior Career Group 55.2% (8,893) (10 years or less to retirement eligibility or retirement eligible)
- 16.4% (2,644) are currently eligible to retire, ↓ from 20.1% in FY08
- Mid Career Group 26.0% (4,183) (11 to 20 years to retirement), 23.9% in FY08
- Future Career Group 18.8% (3,036) (21 to 25+ years to retirement), ↑ from 14.3% in FY08





Certification Level "Meet/Exceed" Rates by Career Field AT&L (FY14Q3)





DAWIA Certification by Component




Certification Level "Meet/Exceed" Rates by Component Life Cycle Logistics (FY14Q3)











Turnover Rates by Career Group







Certification Level "Meet/Exceed" Rates by Component AT&L (FY14Q3)


